
PRESIDENT'S REPORT

ADVOCACY WITH CITY OF KALAMUNDA:

- Climate Change Action Plan adopted!
 - · Reduce City emissions 40% relative to 2020, & 'Net zero' by 2035
 - · Bring community/businesses along the decarbonisation
 - · Advocate to state and federal government
- Tree Retention Policy LPP33 adopted!









- · 'Responsible Cat Ownership' pamphlet update expected soon
 - · Existing pamphlet lacks mention of environmental impacts
- · Fire risk management & contractor damage to reserves
 - · City held 'Impacts of Fire' on-site tour some progress on cool burning
 - However: NRPG believes updated research should be applied ie. Evidence of impact on Southwest forests per Dr Phil Zylstra (and Fire & Biodiversity WA).







ADVOCACY WITH CITY OF KALAMUNDA - Pending:

- Local Biodiversity Strategy
 - · 'Independent review' still in progress
- · Dieback risk mitigation
 - · City improving mapping, signage, hygiene stations, education
- Wattle Grove proposed rezone to "urban" awaiting WAPC decision
 - Threats to Brixton \$t/Yule Book wetlands hydrology raised by NRPG/Prof Hans Lambers
- Water sensitive urban design
 - "Kalamunda Flowing Lower Helena River" public consultation completed
 - · More consultations to follow for each watershed
- · New developments setbacks inadequate
 - City advised ELUPS and LPP Wetlands and Waterways consultation will address this
- Kalamunda Weed "Pest Plant by-laws,1979"
 - · Laws and enforcement under review by City








ADVOCACY WITH STATE GOVERNMENT:

- Guildford Cemetery Bush Forever site under threat of incremental clearing
 - DBCA & Metropolitan Cemetery Board open to land swap to protect it
 - · DBCA not interested in Managing this site
 - NRPG now working with Woodbridge Reserve Friends Group to encourage City of Swan to take on 'Management'
- Bush Forever Audit briefing with DPLH
 - · 85% of sites now reserved for Parks and Recreation
 - · 99% of all original sites still intact
 - More work needed: ongoing funding for land buyback & management; deterioration monitoring, etc.
- · Yule Brook/Foothills Regional Park Proposals
 - Prof Hans Lambers continuing to work with DBCA, DPLH, Enviro Minister Whitby, WAPC
- WA Native Vegetation Policy released
 - · Disappointing inadequate to halt clearing
 - · CCWA, TWS will engage with Minister
- Wilkins Rd Reserve extension of License for Friends Group activities – DPLH
 - · Expect ongoing approval

Forest and woodland cover South West W.A. 1829

Over 90% of the original vegetation in this global biodeversity hotspot has been cleared or severely degraded

Nearly 1/2 of what remains is still available for logging and clearing in 2021

NRPG Grants in 2022

1. Toormaart Creek

Department of Biodiversity, Conservations and Attractions, Regional Parks Unit, Swan Region Parks & Wildlife Service, granted funding to revegetate Toormaart Creek in Gooseberry Hill, through the Parks of the Darling Range Community Advisory Committee grant.

Brian Gould of NRPG managed the project.

\$500 grant money awarded to NRPG on 16/02/22.

\$400.15 paid to Trillion Trees 19/07/22 for 220 seedlings; \$84.20 spent on liquid fertiliser (Bunnings 23/07/22); \$26.97 spent on garden stakes (Bunnings 23/07/22). \$511.32 Total spent.

15/08/22 Brian was reimbursed \$500. Brian chose to donate the remaining \$11.

Phascogale presentations
Organised by Mick Davies.
Mick found an intact deceased phascogale and applied to Department of Primary Industries and Regional Development for funds to raise awareness of Brush-tailed Phascogales across the Perth Hills.

\$5841 was granted on 22/03/22.

\$3300 paid 25/03/22 to the Academy of Taxidermy to preserve the phascogale and create display cabinet.

\$1350 paid 09/05/22 to Uncle Neville Collard for three Welcome to Country ceremonies.

\$132 paid 19/07/22 to Kalamunda Community Centre for hiring the Orange room for presentation.

\$320 paid 09/11/22 to Serpentine Jarrahdale Landcare for presentation venue hire and catering.

\$245 paid 22/11/22 to Kalamunda Hotel for presentation venue hire and catering.

GUEST SPEAKER

A/Prof. Phil Zylstra came into bushfire research from a background in fire management and remote area firefighting.

His work since that time has seen him develop the first and only peer-reviewed fire behaviour model for most Australian forests, as well as the first model globally to calculate the direct effects of fire on flora, fauna and soils.

In his Adjunct role with Curtin University, he has turned his focus toward understanding the ways that our interaction with forests affects fire risk. Using new approaches to analyse fire histories alongside state-of-the-art modelling, Phil has pioneered an approach of "ecological cooperation" that reconciles deep knowledge from First Nations with forest ecology and a complex understanding of fire behaviour to provide critically-needed guidance in fire management.
