9.0 General Business

- **9.1 Statement from Stevie Bruan, Friends of the Northern Jarrah Forest Belt.** Northern Jarrah Forests have been nominated as a UNESCO World Heritage Biosphere site. Has support from Shire of Mundaring who has offered to promote amongst other councils.
- **9.2 Statement from Sue Dowson.** Sue spoke of the impact local tree canopy loss is having on surrounding orchards as Black Cockatoos feed upon orchards. The recent revocation by the City of Kalamunda of Local Planning Policy 33 Tree Retention Policy can only exacerbate the habitat loss.

10.0 Guest Speaker – Dr Giz Watson, Vice President of the Conservation Council of WA (CCWA) on "Safeguarding WA's EPA and Environment"

The CCWA is concerned with the WA Government's recent response to the 39 recommendations from a rapid review of environmental assessment processes and the work of the EPA. The push to amend laws is coming from industry, without community engagement or support.

Approximately 300 mining and development proposals are before the EPA - the CCWA agrees the agency is under resourced.

Giz recently met with Minister Whitby (Minister for Energy; Environment; Climate Action) to ascertain the Governments intentions around reform and the Minister stated the right to appeal decisions will stay.

CCWA and the Beelair Group of Scientists (multidisciplinary group of professors) is providing advice to government as to how to improve environmental laws.

The EPA has for the first time in 66 years announced a review of Alcoa's operations in jarrah forests. The recent decision by Rio Tinto to abandon mining in native forests shows that the sustained pressure from environmental groups and the wider community is effective.

Labour has committed to 400 000ha of new reserves mainly as result of the cessation of logging in native forests – awaiting details.

Through recent reforms within CCWA, it is now in a strong position and the combined effort of CCWA, environmental groups and the community is proving effective at influencing government and industry.


The Climate Change Bill 2023 is weak- no whole of State targets, only govt agencies are required to lower emissions, no independent oversight and weaker than Eastern States legislation. The State does not have an accurate picture of its carbon emissions. The Environmental Defenders Office has reviewed the proposed laws and details are on their website.

The raised temperatures, lower rainfall and lower groundwater tables is placing northern jarrah forests at risk of collapse.

Tree protection policies are under threat, however Giz was of the view tree protection will ultimately win favour due to the range of benefits trees provide.

The 'teals' are playing a game changing role in politics through their green policies. 44% of voters under 35yrs are voting based on environmental issues. The CCWA is providing support and training for the public to advocate effectively.






ADVOCACY WITH STATE GOVERNMENT:

- Guildford Cemetery Bush Forever site under threat of incremental clearing
 - DBCA & Metropolitan Cemetery Board open to 'land swap' to protect it
 - NRPG working with Woodbridge Reserve Friends Group to encourage City of Swan to take on 'Management'
- Darling Range Reg. Park (DRRPCAC)
 - · Community grants awarded for 3 yrs.
 - · DBCA will advertise for Ctee members in future
- Wattle Grove proposed rezone to "urban" awaiting WAPC decision
 - Threats to Brixton St/Yule Book wetlands hydrology raised by NRPG/Prof Hans Lambers
 - City of Kelmscott approved extension of industrial development "Roe Logistics Park" pending EPA & Minister's decision.

 - Enviro Minister Whitby dismissed EPA call for Independent Inquiry on Prescribed Burning
 - Enviro Minister Whitby allowed Alcoa to proceed with new mining while EPA still assessing
- "Black Cockatoo Crisis" documentary (Jane Hammond)
 - Continues showing widely, international awards!
- "Fire & Biodiversity WA" 2021 "Fire and Air Forum" 2023 Outcomes
 - Scientific evidence shows serious flaws with current prescribed burn practice, causing increased fire risk
 - Better ways to manage fire risk sustainably
 - Stop 'prescribed burning', focus resources instead on rapid detection and suppression of wildfires only






Forests protection – logging & mining cont'd

- "End Forest Mining" campaign by WAFA/NJFP/DDFD :
 - NRPG supported 'Objections' & Warden's Court hearings of mining applications in by Alcoa, South32, Rio Tinto.
 - Rio Tinto has withdrawn all forest mining applications!
 - Julimar Forest application by Chalice still pending






BIOGRAPHY - Dr Giz Watson
